By submitting this application, I confirm that I will be participating as a vendor at FULDA GAP 2015. North Carolina Department of Revenue requires collection of sales tax (7.0%) on retail items sold within the boundaries of Alexander County and the state of NC. Command Decisions Wargames Center (CDWC) shall not be liable or otherwise responsible for any damage to, loss, or theft of property within the vending space and shall not be liable or otherwise responsible for any personal injury to the vendor or vendor’s representatives, agents, employees, business invitees, visitors or guests, unless such damage, loss, theft, or personal injury was proximately caused by the gross negligence by CDWC agents.

Vendors must abide by all field rules and local, state, and federal laws at all times. Vendors understand the rules and no tolerance policy related to our “family friendly” policy. No distasteful, offensive, or illegal behavior will be tolerated. Vendors MUST have a working, non-expired, fire extinguisher in their booth for the duration of the event weekend. CDWC encourages vendors insure themselves with special event liability insurance.

Vendors may not sell the following items at this event:

Paintballs (exception: first strike rounds can be sold)	Airsoft BBs over the weight of .36g
Hot burning smoke grenades	Anything that explodes (booby traps/mines/etc.)
Cold burning smoke grenades to anyone under the age of 18	Orange colored Cold burning smoke may not be sold to players (color reserved for game producer’s use only)
Non-sealed eye protection (mesh eye protection is allowed)	Weapons such as knives, machetes, or firearms
Tasers, pepper spray, or any other less-than-lethal weapons other than those directly relating to the play of airsoft	
Medications or alcoholic beverages of any kind	

Vendors Must:

- Obtain a North Carolina Business Certificate of Registration and provide it to CDWC with vendor application.
- Be in the vending area no later than Friday (prior to game day) by noon
- Provide their own booth pop-ups, tables, chairs, fire extinguishers, and power cord unless they arrange to rent them from us. Rentals must be checked back in at the end of game on Sunday, in good condition.
- Provide their prize donation to CDWC vendor liaison (Field Store) as soon as they are set up in their vending space
- Occupy their vending booth at all times during vending hours from 9am until 6pm.
- Abide by all field and vending conduct rules
- **Send us a copy of business logo and a business website hyperlink by September 1 to be included in website promotions. We will resize it to suit the space available on the website**
- **Send all promotional material for players’ packets no later than September 15, 2016.**
